Update on Community Based Adult Services (CBAS) Appeals



After much delay and confusion, the first CBAS appeals from our Adult Day Health Care (ADHC) clients were finally heard last month by an administrative law judge in Oakland. More hearings with our clients are scheduled through July.

Earlier this year, more than 200 beneficiaries from Family Bridges' ADHC Centers were deemed ineligible for CBAS, the replacement program for ADHC, which launched April 1, 2012. All our clients deemed ineligible for CBAS filed appeals and the majority await their day to be heard.

Like many of the 1,800 who have appealed their CBAS eligibility around the state, our ADHC clients and their records were first assessed face-to-face by a state authorized nurse who found them eligible for CBAS. This ruling of eligibility was later overturned in a second level paper review.

Of the handful of clients who have had their appeal hearings, only the first two have received a proposed decision from the judge. Happily, he ruled in their favor. Following standard Medi-Cal procedure, the judge's proposed decision will be reviewed by the Department of Health Care Services (DHCS). DHCS can either adopt the proposed decision or reject it. If DHCS rejects the proposed decision, they will issue their own decision.
